OFFICE MEMORANDUM

Subject: Regarding compliance of the Hon'ble Delhi High Court Order vide dated 10.10.2023 passed in W.P.(C) 13804/2018 titled R. K. (Pvt.) Industrial Training Institute (ITI), Uttar Pradesh Vs DGT

Whereas the petitioner i.e. RK Private ITI, from District-Farrukhabad, Uttar Pradesh, has filed the application on Quality Council of India (QCI) portal bearing application number APP005412 for grant of accreditation of 2(1+1) units in COPA trade on 10.04.2015.

- 2. And whereas the petitioner's application was not recommended by DGT vide order dated 20.09.2018, since the joint inspecting team didn't recommend the application for grant of affiliation. The petitioner case was again put up in 6th Recommendation Committee Meeting held on 31.07.2019 and rejected based upon recommendation made by the team for the re-inspection carried out on 02.05.2019. Being aggrieved with aforesaid decision, the petitioner has filed above subject petition seeking relief to quash the impugned order 20.09.2018, and to direct the respondents to grant the accreditation/affiliation to the Petitioner ITI for 2(1+1+0) units in Trade "COPA" for academic session 2019-20.
- 3. And whereas, the Hon'ble court disposed of the matter on 10.10.2023 inter alia directing the respondent to consider and decide the petitioner's application from session 2024-25. The petitioner was afforded the opportunity to file a fresh application in accordance with affiliation norms 2018. Further, the respondent-DGT shall not charge application fees for the purposes of affiliation, which is ₹10,000/-. However, the petitioner institution shall be liable to pay other charges as may be required by the State Directorate or otherwise.
- 4. That in compliance to above judgement date 10.10.2023, it has been decided that the petitioner can make the online application on the NIMI portal from **01.11.2023 to 30.11.2023** on the link Affiliation Norms for ITIs Year 2019 (www.nimionlineadmission.in) by applying for minimum 4 trades and minimum of 1 units per shift per trade for opening of a new ITI. The petitioner needs to comply the affiliation norms 2018 and latest circulars/orders issued by DGT. Further, the application fees of Rs 10,000/- collected by NIMI, shall be exempted/ refunded in the petitioner case.
- 5. That once the application is received on portal, NIMI will make the special provision to make this application available for completing the activity of desktop assessment (DA) for state directorate UP, irrespective of the pending applications in state directorate login. The state will process the application on priority basis to complete the DA stages. The application fees of Rs 10,000/- shall be exempted or refunded back to the petitioner as per the functionality available on NIMI portal.

6. That, after completion of DA stages and joint inspection by the team, the petitioner case shall be put up before Standing Committee on Accreditation and Affiliation (SCAA) for final decision of accreditation/ affiliation. The trade(s) / unit(s) of Industrial Training Institutes in respect of which the accreditation reports are found conforming to all the requirements as per the latest affiliation norms, are affiliated by the SCAA.

Therefore, in view of above iterated circumstances, the petitioner is requested to apply on the NIMI portal within given timelines, and follow the procedure of affiliation norms 2018 and extant regulations/norms of DGT in order to get the affiliation.

This OM shall not be treated as precedent in any other matters.

This issues with approval of the competent authority in compliance to judgement dated 10.10.2023 passed by the Hon'ble court in the matter of W.P.(C) 13804/2018.
