These applications will be processed in the order they are received, following the completion of pending applications from previous sessions, on a first-come, first-served basis.
- 5. Applicants may also be informed that they must upload valid 'No Objection Certificate' (NOC) from concerned State/UT Directorate while applying on NIMI affiliation portal.
